 Each SSAR consists of the right to receive an amount, in common stock, equal to the excess of the fair market value of a share of
- (11) common stock on the date of exercise over the exercise price of the SSAR. The SSARs vest at a rate of 33% annually over three years, subject to continued employment of the reporting person. Vesting occurs on September 24 of each year, commencing September 24, 2009.
