- (1) The common stock option vested pro rata over a four-year period on each of April 6, 2002, April 6, 2003, April 6, 2004 and April 6, 2005.
- Pursuant to a Qualified Domestic Relations Order ("QDRO") entered into between the reporting person and the reporting person's former spouse, the economic benefits associated with 27% of the shares underlying the common stock option were transferred by the reporting person to his former spouse. The reporting person disclaims beneficial ownership in the shares transferred pursuant to the QDRO.
- (2) Consequently, the amount of the common stock option that was exercised for the benefit of the reporting person was 73% of 25,000 and the amount of the common stock option beneficially owned after the exercise was 0. The reporting person's former spouse is deemed to beneficially owned the remaining portion of the option exercised (6,750 option shares).
