(the "Registrant") which results in an increase in the number of the outstanding shares of the Registrant's Class A Common Stock.
- (2) For the purpose of computing the registration fee, the Registrant has used \$11.255 as the average of the high and low prices of the Class A Common Stock as reported on April 26, 2010 on the NASDAQ Global Market for the offering price per share, in accordance with Rules 457(c) and (h). The actual offering price will be determined in accordance with the terms of the Plan.

(c) To remove from registration by means of a post-effective amendment any of the securities being registered which remain unsold at the termination of the offering.
