- (1) Includes 1,138,607 shares acquired through the reinvestment of dividends on October 2, 2008, January 5, April 2 and July 2, 2009, at prices ranging from \$15.17 to \$27.32 per share.  
The number of underlying securities is based on the stock fund balance on September 30, 2009. The actual number of shares issuable upon the distribution date is not determinable since the stock fund is a unitized account consisting of 96% company stock and 4% money market fund. The stock account balance reflected in this report is based on a September 30, 2009, stock fund price of \$25.56 per share and includes a company match of 522.33 shares.
- (2) Fifty percent of the options vest after two years and the remaining 50% vests after three years.  
Each share of phantom stock is the economic equivalent of one share of Johnson Controls common stock. Shares of phantom stock are payable in cash following the reporting person's termination of employment with the company and may be transferred by the reporting person into an alternative investment account at any time.
- (3) The phantom stock units were accrued under the Johnson Controls Long Term Incentive Plan and are to be settled 100% in cash upon the reporting person's termination of employment with the company.
- (4) Includes 162,962 phantom stock units acquired through the reinvestment of dividends on October 2, 2008, January 5, April 2, July 2, and October 2, 2009, at prices ranging from \$15.02 to \$27.18 per phantom stock unit.  
The phantom stock units were accrued under the Johnson Controls Retirement Restoration Plan and are to be settled 100% in cash upon the reporting person's termination of employment with the company. Phantom stock units accrue in the plan through monthly payroll deductions once the limit has been reached in the 401(k) Plan. The Retirement Restoration Plan mirrors the company's broad-based 401(k) Plan.

The plan mirrors the company's 401(k) plan.
