**MTS Announces Subscriber Growth Numbers for November 2005**

**Moscow, Russian Federation December 9, 2005** Mobile TeleSystems OJSC ( MTS - NYSE: MBT), the largest mobile phone operator in Russia and the CIS, announces that its consolidated subscriber base reached 54.11 million users on November 30, 2005.

During November 2005, MTS consolidated subscriber base increased by 1.68 million subscribers, of which 1.23 million were added in Russia.
