**PART III NARRATIVE**

QuickLogic Corporation (the Company) plans to file its Quarterly Report on Form 10-Q for the quarter ended July 2, 2006 (Form 10-Q) as soon as practicable, but does not expect that it will be filed on or before the fifth calendar day following the required filing date as prescribed in Rule 12b-25.

As described in its current report on Form 8-K dated July 26, 2006, the Company is conducting an internal review of its historical stock option practices and related accounting treatment under the direction of the Audit Committee of its Board of Directors. In response to this Form 8-K, on August 1, 2006 and as described in its current report on Form 8-K dated August 7, 2006, the Company received an informal inquiry from the Securities and Exchange Commission (the SEC) requesting certain documents and information relating to the Company's policies, practices, procedures and public disclosures regarding its stock option grants and related accounting. The Company intends to cooperate fully with the SEC.

At this time, the Company has neither completed its internal review, nor reached any preliminary or final conclusions about its stock option practices and the related accounting treatment. Until the internal review is complete, the Company will be unable to prepare and file its Form 10-Q. The Company intends to file its Form 10-Q as soon as practicable.
