**Moscow, Russian Federation Mobile TeleSystems OJSC ( MTS NYSE: MBT), the largest mobile phone operator in Russia and the CIS, announces that its consolidated subscriber base reached 77.97 million users on September 30, 2007.**

During September 2007, MTS consolidated subscriber base increased by 1.91 million subscribers.
