Portugal Telecom, SGPS S.A. ( PT ) informs that it was notified by Barclays Plc that this entity holds a long position corresponding to less than 2% of PT s share capital and voting rights.

The change resulted from the returning, on 21 January 2013, of 473,286 PT borrowed shares, in an OTC transaction.
