(3) Represents restricted shares granted under the issuer's 2013 Long-Term Incentive Plan effective immediately prior to the consummation of the issuer's initial public offering, including 37,500 restricted shares subject to time-based and performance-based percentage vesting, with any shares becoming earned based upon the issuer's compounded annual book value per share growth percentage during a three-year performance period commencing January 1, 2014, vesting on the one year anniversary of the completion of the performance period, and 37,500 restricted shares subject to time-based vesting, vesting in equal annual installments during the four-year period commencing January 1, 2014.

(4) Includes 35,779 restricted shares granted under the issuer's Annual Leadership Bonus Plan, of which 17,624 vest on January 1, 2014, 11,836 vest on January 1, 2015 and the remaining restricted shares vest on January 1, 2016.
