Item 1.01 Entry into a Material Definitive Agreement.

On November 12, 2004, SBA Senior Finance, Inc. (SBASF), an indirect wholly-owned subsidiary of SBA Communications Corporation (including its subsidiaries, SBA or the Company), entered into a First Amendment to the Amended and Restated Credit Agreement dated as of January 30, 2004, amending its \$400 million senior secured credit facility (the credit facility), among SBA Senior Finance, Inc., as borrower, the lenders from time to time parties thereto, Lehman Brothers Inc. and Deutsche Bank Securities Inc., as Joint Lead Advisors, Joint Lead Arrangers and Bookrunners, Lehman Commercial Paper Inc., as Administrative Agent, General Electric Capital Corporation as Co-Lead Arranger and Co-Syndication Agent, and TD Securities (USA) Inc., as Documentation Agent.

The credit facility consists of a \$75 million revolving credit facility and a \$325 million term loan. The amendment reduces the interest rate on the facility and eliminates or eases certain restrictive provisions. The credit facility now provides for loans at either the Eurodollar rate plus a spread of 275 basis points or the Base Rate (as defined in the credit facility) plus a spread of 175 basis points. Prior to the amendment, the credit facility provided for loans at either the Eurodollar rate plus a spread of 350 basis points or the Base Rate (as defined in the credit facility) plus a spread of 250 basis points. The First Amendment is attached hereto as Exhibit 10.44 and is incorporated herein by reference.
