**Item 5.07. Submission of Matters to a Vote of Security Holders.**

On October 13, 2015, AAR Corp. (the Company) held its 2015 annual meeting of stockholders (the Annual Meeting). At the Annual Meeting, 34,027,591 shares of common stock, par value \$1.00 per share, or approximately 95.80% of the 35,516,483 shares of common stock outstanding and entitled to vote at the Annual Meeting, were present in person or by proxy. Set forth below are the matters acted upon by the Company's stockholders at the Annual Meeting, as described in the Company's proxy statement filed on August 28, 2015, and the final voting results on each such matter.

Proposal 1: Election of Directors.

The stockholders elected each of the Company's three Class I director nominees for a three-year term expiring at the 2018 annual meeting, as reflected in the following voting results:

Proposal 2: Advisory Vote on Executive Compensation.

The stockholders approved the advisory vote on executive compensation for the fiscal year ended May 31, 2015, as reflected in the following voting results:
