UCMHI is the beneficial owner of 178,648 shares of Ocwen's common stock indirectly through UAHI, a wholly-owned subsidiary of UCMHI. Devaney controls UREVI and UCMHI and therefore may be deemed to be the beneficial owner of the 1,624,694 shares of Ocwen's common stock owned directly and indirectly by UREVI and UCMHI. Devaney may also be deemed to be the beneficial owner of 5,194,517 shares of Ocwen's common stock controlled personally and through retirement accounts. All figures are as of December 31, 2016. Percentages are based on 123,989,954 shares of Ocwen's common stock outstanding as of October 25, 2016, as reported in the Form 10-Q filed by Ocwen on October 27, 2016.
