- (1) On May 4, 2016, the board of directors made an award of 12,000 shares of restricted stock to Mr. Kilmer. A block of 2,400 performance shares may be eligible for vesting on December 31, 2019 based on the attainment of customer satisfaction goals. The stock has voting rights and will fully vest on an earlier date if a change of control occurs.
