Section 1 - Registrant's Business and Operations

Item 1.01 Entry into a Material Definitive Agreement

On April 25, 2005, the Board of Directors of NovaMed, Inc. (the "Company") approved the Company's 2005 Stock Incentive Plan ("Plan") pursuant to which 1,400,000 shares of the Company's common stock were authorized to be issued on the terms set forth in the Plan. The Board of Directors approved the Plan subject to the Company's stockholders approving it at the Company's annual meeting of stockholders on June 15, 2005. At the June 15^h stockholders' meeting in which a quorum was present in person or by proxy, the Company's stockholders approved the Plan, with 10,110,250 shares voting in favor of the Plan, 2,981,239 shares voting against the Plan, and 130,830 shares abstaining.
