The aggregate number of shares to which this Schedule 13G relates is 145,684 shares which is comprised of 81,130 shares of common stock (cusip 859166100) and 64,554 warrants (cusip 859166118), representing 5.04% of the 2,893,014 shares outstanding. This latter number is arrived at by adding the number of shares outstanding as reported in the issuer's most recent 10-Q filing for the quarterly period ended 10/31/2007 (2,828,460) plus the warrants issued to the reporting person (64,554).

Note 1. Mariner, an investment adviser registered under Section 203 of the Investment Advisers Act of 1940, furnishes investment advice to several investment companies exempt from the Investment Company Act of 1940, and serves as investment manager to certain other separate accounts. These investment companies and accounts are collectively referred to as the "Funds".
