Item 8.01 Other Events.

On March 12, 2015, OFS Capital WM, LLC (“OFS Capital WM”), a wholly-owned subsidiary of OFS Capital Corporation (the “Company”), elected unilaterally to permanently and irrevocably reduce the size of its secured revolving credit facility (the “WM Credit Facility”) with Wells Fargo Bank, N.A. (“Wells Fargo”) under a Loan and Security Agreement among OFS Capital WM, MCF Capital Management LLC (“MCF”), Wells Fargo Securities, LLC, each of the Lenders from time to time party thereto, and Wells Fargo Delaware Trust Company, N.A. (the “Loan and Security Agreement”), from \$100 million to \$75 million (the “Reduction”), by written notice to Wells Fargo and MCF under the Loan and Security Agreement. The Reduction will result in a lowering of OFS Capital WM’s interest expenses, attributable to a reduction of its non-usage fee, in connection with the WM Credit Facility. No costs were incurred by the Company or OFS Capital WM in connection with the Reduction.

The foregoing description of the WM Credit Facility does not purport to be complete and is qualified in its entirety by reference to the original Loan and Security Agreement dated as of September 28, 2010, as amended by the First Amendment thereto dated as of November 27, 2010, the Second Amendment thereto dated as of January 26, 2011, the Third Amendment thereto dated as of September 28, 2012, the Fourth Amendment thereto dated as of January 22, 2013, the Fifth Amendment thereto dated as of April 3, 2013, the Sixth Amendment thereto dated as of November 22, 2013, the Seventh Amendment thereto dated as of January 17, 2014, and the Eighth Amendment thereto dated as of July 24, 2014.
