- (6) Pursuant to the Articles of Incorporation of the Company, as amended, shares of Class B Common Stock (voting) of Erie Indemnity Company are convertible at any time to shares of Class A Common Stock (non-voting) at a conversion rate of 2,400 shares of Class A Stock for each share of Class B Stock.
- (7) The reporting person became a beneficial owner of more than 10% of the Company's Class B Common Stock under Rule 16a-1-(a)(1) on July 20, 2007, upon her acceptance of her appointment to serve as an individual trustee of the H. O. Hirt Trusts, which hold the shares of Class B Common Stock indicated.
