("CCE Spinco") that it owns to its shareholders of record on December 14, 2005. The distribution will be made to shareholders of Clear Channel on a pro rata basis by means of a share dividend. On or prior to the distribution date, CCE Spinco will recapitalize the CCE Spinco common stock held by Clear Channel such that Clear Channel will distribute to its shareholders one share of CCE Spinco common stock for every eight (8) shares of Clear Channel common stock held by shareholders of Clear Channel on December 14, 2005.
