- (1) Reflects the issuance of CUB common stock upon vesting of restricted stock units ("RSUs"). Each RSU granted at that time represented a contingent right to receive one share of CUB stock.
- (2) Shares withheld by CUB to satisfy the minimum statutory tax withholding obligations that arose upon the vesting of RSUs.
- (3) This is the first of 2 vesting installments of RSUs granted to the Reporting Person on December 12, 2013. The remaining 816 shares from such grant shall vest on October 1, 2015, subject to the Reporting Person's continuous service through each application vesting date.
- (4) The RSU vests in two installments, 1/3 on October 1, 2014, and 2/3 on October 1, 2015, subject to the Reporting Person's continued service as a director with CUB through such date.
- (5) Last Form 4 transaction reported incorrect total of RSU grant on Table II. The amount of the grant should have been 1,225 rather than 1,634.
