## Explanation of Responses:

- (1) Reflects the issuance of CUB common stock upon vesting of restricted stock units ("RSUs"). Each RSU granted at that time represented a contingent right to receive one share of CUB stock.
  - (2) Shares withheld by CUB to satisfy the minimum statutory tax withholding obligations that arose upon the vesting of the RSUs.
  - (3) Represents shares held by the Reporting Person's 401(k).
  - (4) This is the fourth and final of 4 vesting installments of RSUs granted to the Reporting Person on December 12, 2013.
  - (5) This is the third of 4 vesting installments of RSUs granted to the Reporting Person on November 6, 2014. The remaining 208 shares from such grant shall vest on October 1, 2018, subject to the Reporting Person's continuous service through each application vesting date.  
This is the second of 4 vesting installments of RSUs granted to the Reporting Person on November 6, 2015. The remaining 437 shares from such grant shall vest in 2 equal installments on October 1, 2018 and 2019, subject to the Reporting Person's continuous service through such application vesting date.
  - (6) This is the first of 4 vesting installments of RSU's granted to the Reporting Person on November 14, 2016. The remaining 651 shares from such grant shall vest in 3 equal installments on October 1, 2018, 2019 and 2020, subject to the Reporting Person's continuous service through each application vesting date.
