The number of derivative securities beneficially owned in column 9 includes 14.5996 dividend equivalent rights at \$44.96 per RSU credited to the reporting person's account on 07/07/10, and 16.1119 dividend equivalent rights at \$40.74 per RSU credited to the reporting person's account on 10/06/10.
