(1) On March 27, 2007, the reporting person became entitled to receive an additional 281,630 shares of Encorium Group, Inc.'s ("Encorium") common stock pursuant to an "earn-out" provision contained in the Amended and Restated Combination Agreement dated July 6, 2006 (the "Agreement"), pursuant to which Encorium acquired all of the issued and outstanding stock of Remedium Oy ("Remedium") on November 1, 2006. The Agreement provided that the former stockholders of Remedium would receive a variable number of additional shares of Encorium common stock, for no additional consideration, if Remedium's net revenues for the year ending December 31, 2006 reached certain threshold levels contained in the Agreement. Remedium's net revenues for the year ending December 31, 2006 exceeded EUR 9,500,000, but was less than EUR 10,700,000, as a result of which the former stockholders of Remedium, including the reporting person, acquired additional shares of Encorium common stock pursuant to the Agreement.

(2) The number of shares issuable pursuant to the earn-out right was determined pursuant to a formula set forth in the Agreement which provided that, for the purpose of determining the number of shares issuable, Encorium's common stock would be valued at \$2.83 per share, representing the price per share at which the former Remedium stockholders received Encorium shares upon the closing of the Agreement.
