- (1) On May 5, 2008, Mr. Kirloskar received a grant of restricted stock units ("RSUs") covering 8,000 shares of KLA-Tencor common stock. On May 5, 2010, Mr. Kirloskar vested in fifty percent (50%) of such RSUs.
- (2) Pursuant to the terms of the May 5, 2008 RSU grant, 1,489 shares of KLA-Tencor common stock were automatically withheld at vesting to cover required tax withholding. The fair market value of KLA-Tencor common stock used for purposes of calculating the number of shares to be withheld was the closing price of KLA-Tencor common stock as reported on the NASDAQ Stock Market on such vesting date.
- (3) Each RSU represents a contingent right to receive one share of KLA-Tencor common stock.
