(1) The Reporting Person was granted 10,664 shares of Restricted Common Stock under the 2013 Stock-Based Compensation Plan. 3,490 time-vested restricted shares vest over a three year period as follows: 1,164 time-vested restricted shares on February 28, 2018 and 1,163 time-vested restricted shares on February 28, 2019 and 2020, respectively. 3,684 performance-based restricted shares vest on February 28, 2020 based on the Company's Total Shareholder Return versus a defined peer group of companies, with the final number of performance-based vested shares varying from 0 to 200% of 3,684. 3,490 performance-based restricted shares vest on February 28, 2020 based on the Return on Invested Capital achieved by the Company compared to the ROIC target varying from 0 to 200% of 3,490.
