**Item 5.02. Departure of Directors or Certain Officers; Election of Directors; Appointment of Certain Officers; Compensatory Arrangements of Certain Officers**

By a resolution of the board of directors dated May 7, 2009, Innospec Inc. appointed its President and CEO, Patrick S. Williams as an executive director of the Company. The resolution appoints Mr Williams as a director until the next Annual Meeting of Shareholders of Innospec Inc. when Mr Williams may be nominated for election for a term of three years.

Mr Williams was appointed as the Company's President and Chief executive officer on April 2, 2009, prior to which he was Executive Vice President and President, Fuel Specialties with the Company since 2005.

The material employment terms of Mr Williams were furnished with the recent Form 8-K filed by the Company on April 3, 2009.
