- (1) Each share option represents the right to purchase one common share, par value \$1.00 per share, of MF Global Ltd. (each a "Common Share"). The share options are subject to the terms and conditions of the MF Global Ltd. 2007 Amended and Restated Long Term Incentive Plan. One-third of the share options will vest on each of the first, second and third anniversaries of June 22, 2009, the grant date (becoming fully vested on June 22, 2012, the third anniversary of the grant date). Each share option becomes exercisable upon vesting.
- (2) Each restricted share unit represents a contingent right to receive one Common Share and will be subject to the terms and conditions of the MF Global Ltd. Amended and Restated 2007 Long Term Incentive Plan. All of these restricted share units will vest on June 22, 2012, the third anniversary of the grant date. Vested restricted share units will be delivered upon vesting, except in certain limited circumstances described in the award agreement.
