("ETP") in exchange for the interests in an entity that owns a 49.9% interest in Midcontinent Express Pipeline, LLC (1) ("MEP") and the option to acquire the equity interests in the entity that owns the remaining 0.1% interest in MEP after 12 months and one day following the closing of the initial transfer of the MEP interest. The estimated market value of the 49.9% interest in MEP (and the option) is \$600 million.
