- (1) Grant of restricted stock units which vest in three installments -- 20% on the first anniversary of the date of grant, 30% on the second anniversary of the date of grant and the remaining 50% on the third anniversary of the date of grant.

- (2) The reporting person made an irrevocable election in November 2012 to satisfy tax withholding obligations relating to the vesting of shares of Common Stock previously awarded through the deduction of shares from the vested amount.
