- (1) 385 shares were withheld from the 1,200 restricted shares that vested on June 1, 2015. These 1,200 shares were awarded to Mr. Zangerle on May 31, 2011 as part of an award of 1,200 restricted shares. These vested shares were valued at the NYSE closing market price on June 1, 2015.
