Unilever NV announces that on 10 July 2007 it purchased 100,000 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 23.450 and euro 24.160 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 95,174 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 79,182,814 Unilever NV ordinary shares in treasury, and has 1,635,544,886 Unilever NV ordinary shares in issue (excluding treasury shares).
