- (d) On January 24, 2008, the Board of Directors (the Board) of Arthur J. Gallagher & Co. (Gallagher) unanimously resolved to increase the size of the Board from 9 to 10 directors in accordance with applicable provisions of Gallagher's By-laws. Also on January 24, 2008, in accordance with applicable provisions of Gallagher's Restated Certificate of Incorporation and By-laws, the Board elected Norman L. Rosenthal, Ph.D. to serve as a Class III Director, effective immediately, to fill the vacancy created by the increase in the size of the Board and to serve until he stands for re-election at the 2008 Annual Meeting of Stockholders of Gallagher. Concurrently with his election to the Board, Mr. Rosenthal was elected to serve on the Audit Committee of the Board.

There is no arrangement or understanding between Mr. Rosenthal and any other person pursuant to which Mr. Rosenthal was elected as a Director of Gallagher.
