**ChipMOS REPORTS SEPTEMBER 2008 REVENUES**

**Hsinchu, Taiwan, October 16, 2008** ChipMOS TECHNOLOGIES (Bermuda) LTD. ( ChipMOS or the Company ) (NASDAQ: IMOS) today reported its unaudited consolidated revenues for the month of September 2008.

Revenues for the month of September 2008 were NT\$1,300.1 million or US\$40.3 million, a decrease of 13.6% from the month of August 2008 and a decrease of 36.3% from the same period in 2007. On a quarterly basis, revenues for the third quarter of 2008 were NT\$4,361.5 million or US\$135.3 million, a decrease of 9.5% from the second quarter of 2008 and a decrease of 26.6% from the same period in 2007. (All translations from NT dollars to U.S. dollars were made at the exchange rate of NT\$32.23 against US\$1.00 as of September 30, 2008.)
