Cargo Fleet Service Clerks,

Today represents an exciting step in our airline's history. American will welcome our colleagues at US Airways to create the world's largest airline with an expanded network that will offer more opportunities for our customers and our people.

I know you are probably wondering what this merger will mean for you, and I wanted to take a moment to personally address this for you and your Cargo Fleet Service Clerk colleagues.

You probably won't notice a lot of changes to your jobs in the short-term. Until the merger closes, American and US Airways will continue to operate as separate airlines. For our domestic U.S.-based Fleet Service Clerks, the current Collective Bargaining Agreement (CBA) will remain in effect. The CBA will remain in place until the closing of the merger, which is conditioned on government and US Airways stockholder approval, Bankruptcy Court approval and other customary closing conditions. We anticipate the merger being completed in the third quarter of 2013. At that point, the MOU between American, US Airways and the TWU will modify certain provisions of the CBA, and those modified terms will remain in effect until a new Joint Collective Bargaining Agreement (JCBA) is reached for the combined workgroup.

We'll continue to provide you with information as it becomes available. I'd also encourage each of you to visit the new Jetnet for more details about today's news, including answers to other questions you may have and what we can expect in the coming months.

The past year has been difficult for all of us, but I think the changes ahead of us will be exciting, and our efforts to build a premier global carrier will be well worth it. Today we begin a lengthy process of planning to combine our two airlines, and your contributions will be the key to ensuring the success of the new American. More than anything else, your incredible service every day is what will make this transition—and this merger—a success. We've got the right team in place to make that happen, and I thank all of you on the front lines for your hard work and dedication.
