On April 28, 2011, Exelon sent the following message to certain of its employees:

Message from Ruth Ann Gillis

This message is being sent to all BSC employees on behalf of Ruth Ann Gillis, executive vice president and chief administrative and diversity officer, Exelon and president, Business Services Company.

Dear Colleagues:

By now, you have seen the news that Exelon has agreed to merge with Constellation Energy. This is exciting news and provides a growth platform for both of our companies by matching Exelon's industry clean generation fleet with Constellation's leading retail/wholesale energy business.

I understand with change comes concern. You may wonder what this means for you. There are still many unknowns, and things that will be worked out during the integration process. But there are a few things we know for certain:

First, **the transaction will take time** Exelon does not expect to close this merger until early 2012

Second, **the success of this merger is not based solely on synergies** While there will certainly be opportunities to realize savings through some consolidation of corporate functions and specific technologies, we will attempt to avoid massive restructuring or terminations. To help minimize the impact on employees, we will be taking several steps including the elimination of unfilled positions where feasible and by offering relocation plans where positions will be moving locations and the employee is asked to move. An example of a pending move is Power Team which will eventually move to Baltimore, along with some BSC positions supporting that operation.

Third, **we need to stay focused**. The transaction could become distracting if we allow it. We need to stay focused on the blocking and tackling of our day to day jobs.

You have my commitment, and that of the BSC leadership team, to open, transparent and complete information as soon as we can share it. In this regard, the integration team under Ron DeGregorio's leadership will be working through the merger details providing frequent information as the integration planning progresses.

Finally, I know I can count on our organization to continue its excellent work toward our Vision, and on those who will be working directly on our merger with Constellation to represent our values of respect and integrity throughout this important process.
