**Item 8.01 Other Events.**

On August 2, 2011, Dominion Resources, Inc. (the Company) entered into an underwriting agreement (the Underwriting Agreement) with Barclays Capital Inc., BNP Paribas Securities Corp. and RBC Capital Markets, LLC, as Representatives for the underwriters named in the Underwriting Agreement, for the sale of \$500,000,000 aggregate principal amount of the Company's 2011 Series C 4.90% Senior Notes due 2041. Such Senior Notes, which are designated the 2011 Series C 4.90% Senior Notes due 2041, are Senior Debt Securities that were registered by the Company pursuant to a registration statement on Form S-3 under Rule 415 under the Securities Act of 1933, as amended, which registration statement became effective on January 29, 2009 (File No. 333-157013). A copy of the Underwriting Agreement, including exhibits thereto, is filed as Exhibit 1.1 to this Form 8-K.

The Forty-Third Supplemental Indenture to the Company's June 1, 2000 Senior Indenture, pursuant to which the 2011 Series C 4.90% Senior Notes due 2041 will be issued, is filed as Exhibit 4.3 to this Form 8-K.
