PepsiCo, Inc. (PepsiCo or the Company) and Maura Abeln Smith entered into a separation agreement, dated October 18, 2012, in connection with Ms. Smith is previously announced departure from the Company. Pursuant to the agreement, Ms. Smith is eligible to receive payments, less applicable taxes, consisting of six bi-weekly payments of \$157,150, commencing October 19, 2012 and ending December 28, 2012; a payment of \$2,478,550 in January 2013 and three monthly payments of \$826,183.33 commencing in February 2013 and ending April 2013, as well as continued health benefits. In consideration for the payments, Ms. Smith has agreed to provide consulting services for the Company, to respond to requests for assistance from the Company related to matters arising during her employment, to non-competition, non-solicitation, non-disparagement and confidentiality restrictions and to a general release of any potential claims against the Company.

A copy of the separation agreement between Ms. Smith and the Company is attached hereto as Exhibit 10.1 and is incorporated herein by reference.

In addition, as previously disclosed, John Compton, formerly President of PepsiCo, notified PepsiCo of his decision to resign from the Company. Mr. Compton s resignation is effective October 19, 2012.
