The notes offered in this offering (the new notes) are being offered as additional debt securities under an indenture dated as of May 27, 2011, pursuant to which the Company previously issued \$250,000,000 aggregate principal amount of 5.75% Senior Notes due 2017 (the existing notes and together with the new notes, the notes). The new notes and the existing notes will vote as one class under the indenture governing the notes.
