This Amendment No. 16 (the Amendment ) amends and supplements the Solicitation/Recommendation Statement on Schedule 14D-9 of Complete Genomics, Inc. ( Complete or the Company ) filed with the Securities and Exchange Commission (the SEC ) on September 25, 2012 and amended on September 27, 2012, October 2, 2012, October 5, 2012, October 22, 2012, November 2, 2012, November 13, 2012, November 15, 2012, November 20, 2012, November 26, 2012, November 27, 2012, November 28, 2012, December 7, 2012, December 13, 2012 and December 17, 2012 (as amended, the Schedule 14D-9 ). The Schedule 14D-9 relates to the tender offer by Beta Acquisition Corporation, a Delaware corporation ( Purchaser ) and a wholly owned subsidiary of BGI-Shenzhen, a company organized under the laws of the People's Republic of China ( Parent or BGI ), to purchase all of the outstanding common stock, par value \$0.001 per share, of Complete (the Shares ), at a price of \$3.15 per Share, net to seller in cash, without interest and less any applicable withholding taxes, upon the terms and conditions set forth in the Offer to Purchase dated September 25, 2012 (the Offer to Purchase ) and the related Letter of Transmittal (which, together with the Offer to Purchase, as each may be amended or supplemented from time to time, constitute the Offer ). The Offer is described in a Tender Offer Statement on Schedule TO filed by Parent and Purchaser with the SEC on September 25, 2012. The Offer to Purchase and the Letter of Transmittal were filed with the Schedule 14D-9 as Exhibits (a)(1)(A) and (a)(1)(B), respectively.

Except as otherwise set forth below, the information set forth in the Schedule 14D-9 remains unchanged and is incorporated by reference as relevant to the items in this Amendment. Capitalized terms used and not defined herein shall have the meanings assigned to such terms in the Schedule 14D-9. This Amendment is being filed to reflect certain updates as reflected below.

**Item 8. Additional Information.**

*Item 8 of the Schedule 14D-9 is hereby amended and supplemented to add to the end of the Section entitled "Extension of the Offer" the following:*

On December 28, 2012, Parent and Purchaser announced an extension of the expiration date of the Offer until 12:00 midnight, New York City time, on Monday, January 7, 2013 (which is the end of the day on January 7, 2013). Computershare Trust Company, N.A., the depositary for the Offer, has indicated that, as of the close of business on December 28, 2012, approximately 17,822,265 Shares, or 50% of the outstanding Shares, have been validly tendered in and not withdrawn from the Offer, including Shares subject to guaranteed delivery procedures.

The press release announcing the extension of the Offer is attached hereto as Exhibit (a)(2)(I) and is incorporated herein by reference.

*Item 8 of the Schedule 14D-9 is hereby amended and supplemented to replace the last two sentences of the final paragraph of the Section entitled "Antitrust Compliance - Exon-Florio" with the following:*

On December 28, 2012, CFIUS formally notified Parent and the Company that CFIUS had completed its review of the joint voluntary notice submitted by Parent and the Company and had granted clearance of Parent's proposed acquisition of the Company pursuant to the Merger Agreement. On December 28, 2012, Parent and the Company issued a joint press release announcing the CFIUS clearance, a copy of which is attached hereto as Exhibit (a)(2)(J) and is incorporated herein by reference.
