Canadian Team,

Today is truly a momentous day for our airline. The planned merger with our colleagues at US Airways will form the world's largest airline and will bring additional benefits to our people and our customers. It's important to me to share what today's news means and what's in store for you.

The new American will give our customers more options, a better travel experience, and enhanced connectivity with our oneworld partners. We'll be in a better position to compete and win against Delta, United and other global carriers. This will mean long-term stability for our company, as having an expanded network and wider customer base will bring more opportunity.

All of this will take time. In the immediate future, you won't see a lot of merger-related changes. We'll continue to operate as separate carriers while we work to obtain U.S. regulatory and US Airways shareholder approval of the merger and Bankruptcy Court approval of our Plan of Reorganization, which we expect to take place in the third quarter of 2013.

After the merger closes, we'll then begin the full integration process, which could take a couple years to complete. I know you have questions regarding how this will uniquely impact you and your colleagues in Canada, given the labor and legal framework. We will have additional local communications for our Canada employees.

We will be communicating throughout this process to keep you informed. I urge you to use the new Jetnet as a resource for frequently asked questions and next steps. We'll be posting updates frequently, so check back often.

There will, of course, be changes as we move forward, and it will be important for all of us to remain focused. We can't let anything distract us from our focus on our customers as we work toward making the new American the best airline in the world. Our competitors are surely looking for us to be distracted!

Thank you for the hard work you put into your job and the dedication you show to our airline every single day.
