On April 23, 2014, Greenhill & Co., Inc. ( Greenhill or the Firm ) issued a press release announcing its financial results for the fiscal quarter ended March 31, 2014. A copy of the press release is attached hereto as Exhibit 99.1 and is incorporated herein by reference.

(a) Greenhill held its annual meeting of stockholders on April 23, 2014.

(b) At the annual meeting, Greenhill's stockholders voted on (1) the election of six directors, (2) an advisory vote on Greenhill's executive compensation and (3) the ratification of the selection of Ernst & Young LLP as Greenhill's independent auditors for the fiscal year ending December 31, 2014.

The votes cast by the holders of Greenhill's common stock on each of the foregoing proposals were as follows:

Proposal 1 Election of six directors.
