On April 30, 2014, pursuant to an Agreement and Plan of Merger dated April 29, 2014, by and among Red Hat, Inc., a Delaware corporation ( Red Hat ), Inktank Storage, Inc., a Delaware corporation ( Inktank ), Diamond Software Acquisition Corp., a Delaware corporation and a wholly-owned subsidiary of Red Hat ( Diamond ), and Fortis Advisors LLC, as holder agent, Red Hat completed its previously announced acquisition of Inktank through a merger of Diamond with and into Inktank. Inktank develops, distributes and provides support for open source storage software.
