Investment description

### Linked to the Health Care Select Sector SPDR® Fund

Instead, the securities provide for a payment at maturity that may be greater than, equal to or less than the original offering price of the securities, depending on the performance of the Fund from its starting price to its ending price.

The payment at maturity will reflect the following terms:

### o If the value of the Fund increases:

You will receive the original offering price plus 115% to 125% (to be determined on the pricing date) participation in the upside performance of the Fund

#### o If the value of the Fund decreases but the decrease is not more than 20%:

You will be repaid the original offering price

### o If the value of the Fund decreases by more than 20%:

You will have full downside exposure to the decrease in the value of the Fund from the starting price, and you will lose more than 20%, and possibly all, of the original offering price of your securities

If the ending price is less than or equal to the starting price, but greater than or equal to the threshold price, the redemption amount will be equal to \$1,000

If the ending price is less than the threshold price, the redemption amount will be equal to \$1,000 minus

If the ending price is less than the threshold price, you will lose more than 20%, and possibly all, of the original offering price of your securities at maturity.
