The technical report attached as Exhibit 99.1 to this Form 6-K has been prepared in accordance with the requirements of the securities laws in effect in Canada, which differ from the requirements of United States securities laws.

The terms mineral reserve , proven mineral reserve , probable mineral reserve , mineral resource , measured mineral resource , indicated mineral resource and the terms reserves , resources , geologic reserves , probable , measured , indicated , or inferred are Canadian mining terms as defined in accordance with Canadianal Instrument 43-101 Standards of Disclosure for Mineral Projects (NI 43-101) and the Canadian Institute of Mining, Metallurgy and Petroleum (the CIM) CIM Definition Standards on Mineral Resources and Mineral Reserves, adopted by the CIM Council, as amended. These definitions differ from the definitions in the Securities and Exchange Commission s (the Commission) Industry Guide 7 (Industry Guide 7) under the Securities Exchange Act of 1934, as amended, and are normally not permitted to be used in reports and registration statements filed with the Commission. Under Industry Guide 7 standards, a final or bankable feasibility study is required to report reserves, the three-year historical average price is used in any reserve or cash flow analysis to designate reserves and the primary environmental analysis or report must be filed with the appropriate governmental authority.
