**Novo Nordisk A/S – Share repurchase programme**

**Bagsværd, Denmark, 29 January 2014** – On 31 October 2013, Novo Nordisk initiated a share repurchase programme in accordance with the provisions of the European Commission’s regulation no 2273/2003 of 22 December 2003, also referred to as the Safe Harbour rules. This programme is part of the overall share repurchase programme of up to DKK 14.0 billion to be executed during a 12-month period beginning 31 January 2013.

Under the programme initiated 31 October 2013, Novo Nordisk has repurchased B shares for an amount of DKK 2.8 billion in the period from 31 October 2013 to 28 January 2014. The programme initiated 31 October 2013 is thereby concluded.

Since the announcement as of 20 January 2014, the following transactions have been made under the programme:
