- Each Performance Unit entitles the holder to the value of one common share. The Units are payable 60% in common stock and 40% in cash. One half of the Units vested at grant and one half vested in installments, each equaling 1/36th of the total number of Units, beginning October 17, 2006 and continuing until the Units were fully vested in March 2008. Units are held in a deferred compensation account, 25% of which was paid on April 30, 2008, and 25% of which will become payable on each of April 30, 2009, 2010 and 2011.
- (1) Until payout, Units were subject to anti-dilution adjustment, effected by the issuance of additional Units, upon conversions of the Issuer's Series A Preferred and 10% Senior Convertible Notes, all of which have now been converted or redeemed. Since the grant date on September 29, 2006, an aggregate of 124,001 additional Units were granted as a result of such adjustments. The Units remain subject to adjustment for stock splits and similar events.
