On September 25, 2006, Mr. DeGroot was granted an award of 116 restricted stock units ("RSUs"). 29 shares were issued to Mr.

(1) DeGroot in December 2007 and 29 shares were issued in August 2008 in partial settlement of such grant. The remainder of the grant was scheduled to settle in two equal installments on December 31 in each of 2009 and 2010.

(3) On September 25, 2006, Mr. DeGroot was granted an award of 188 RSUs. The grant was scheduled to settle in four equal installments on December 31 in each of 2009, 2010, 2011 and 2012.
