Holders of Class A Common Stock and Class B Common Stock generally have identical rights, except that holders of Class A Common Stock are entitled to one vote per share while holders of Class B Common Stock are entitled to ten votes per share on matters to be voted on by shareholders.

(1) Shares of Class B Common Stock are convertible into Class A Common Stock on a one-for-one basis for no additional consideration at any time, with no expiration date, upon voluntary conversion by the holder of such shares or upon any sale or transfer of such shares with certain exceptions.

(2) Represents distribution of shares from the Robert Y. Greenberg 2009 Annuity Trust, of which Gil Schwartzberg is trustee ("2009 RYG GRAT"), to the Greenberg Family Trust, of which Robert and Susan Greenberg are co-trustees, under the terms of the 2009 RYG GRAT.

(3) Represents distribution of shares from the M. Susan Greenberg 2009 Annuity Trust, of which Gil Schwartzberg is trustee ("2009 MSG GRAT"), to the Greenberg Family Trust, of which Robert and Susan Greenberg are co-trustees, under the terms of the 2009 MSG GRAT.
