On March 9, 2011, Hercules Holding II, LLC distributed for no consideration 174,865 shares of HCA Holdings, Inc.'s common stock, par value \$.01 per share ("Common Stock"), previously held for the account of funds advised by Bain Capital, to such funds, which funds made a further distribution of shares to certain partners and other employees of Bain Capital in connection with certain charitable gifts made by such partners and other employees on March 9, 2011. Hercules Holding II, LLC is held by a private investor group, including affiliates of Bain Capital Partners, LLC, Kohlberg Kravis Roberts & Co. L.P. and Merrill Lynch Global Private Equity, and affiliates of HCA Holdings, Inc. founder Dr. Thomas F. Frist, Jr. Each of such persons, other than Hercules Holding II, LLC, disclaims membership in any such group and disclaims beneficial ownership of these securities, except to the extent of its pecuniary interest therein.
