(1) This entry represents the number of shares of ViaSat, Inc. common stock withheld by the Issuer to satisfy the tax withholding obligation of the Reporting Person. (3) Until vested, the restricted stock unit shall be subject to forfeiture in the event of termination of employment or service with the issuer.
