("Trian Management"), which serves as the management company for Trian Partners, L.P. ("Trian Onshore"), Trian Partners Master Fund, L.P. ("Trian Offshore"), Trian Partners Parallel Fund I, L.P. ("Parallel Fund I") and Trian Partners Strategic Investment Fund, L.P. ("Strategic Fund" and collectively, the "Trian Funds").
    - (2) (FN 1, contd.) Trian Partners General Partner, LLC is the general partner of Trian Partners GP, L.P., which is the general partner of Trian Onshore and Trian Offshore. Trian Partners Parallel Fund I General Partner, LLC is the general partner of Parallel Fund I. Trian Partners Strategic Investment Fund General Partner, LLC is the general partner of Trian Partners Strategic Investment Fund GP, L.P., which is the general partner of Strategic Fund.

Thus, in total, there are Management, L.P. ("Trian Management") and each of the other persons that is a signatory to this Form 4. Nelson Peltz, Peter Management GP, LLC, the general partner of Trian Management, which serves as the management company for each of Trian Fund I, L.P. and Trian Partners Strategic Investment Fund, L.P., and are members of Trian GP LLC, the general partner of Trian and voting decisions made on behalf of each of the 11 joint filers. Messrs. Peltz, May and Garden currently report their holding

separate filings. The transactions reported in this filing and the filing by the other joint filers are also reported in the filings made in each case relate to the same securities.
